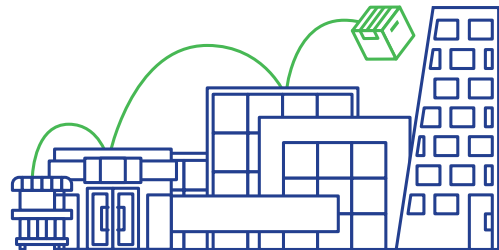
Going Digital with Bills of Exchange
