How does iCOR work?

iCOR contains a comprehensive database of current UK environmental and health & safety legislation, all presented in easily understood language and summarised versions. The intelligent compliance obligations register is built in the following steps:







Aligning with ISO14001

iCOR specifically focuses on ISO14001 clauses that organisations struggle most with, including:

- Clause 6.1.3 Compliance Obligations Organisations are required to have access to, and maintain awareness of environmental legislation. Answering iCOR's simple audit builds your organisation's bespoke compliance register.
- Clause 6.1.4 Planning Action This clause looks at how your organisation's action planning to improve environmental performance. iCOR determines the sufficiency of your controls, writes your compliance statements, and identifies gaps where regulatory requirements or internal commitments are not met.
- Section 7 Support This section relates to resource allocation, competency, awareness and communication, all supported via iCOR's action planning function, and mechanisms for team collaboration. Often, solutions for compliance when planning action are additional training and communication strategies to support the EMS.
- Clause 9.1.2 Evaluation of Compliance Your answers to iCOR's simple audit questions about your organisation's business activities serves to determine your status of compliance at any point in time. Risks are identified in relation to key environmental areas in order to prioritise your action planning.
- Clause 9.1.1 Monitoring, Measuring, Analysis and Evaluation This clause requires the audit results to be accurate and consistent for the ease of reporting. iCOR visually represents the audit results to easily interpret your current 'status of compliance' showing areas of conformity and progress towards improvement. iCOR's timeline function also tracks performance over time. iCOR's incident reporting function allows to raise and address environmental concerns outside of the structured audit to ensure that issues are managed pro-actively and evidence is obtained.
- Clause 10.2 Non-Conformity and Corrective Action This clause states the organisation
 must implement procedures for the management of non-conformities. iCOR identifies your
 compliance status; any non-conformities are transposed into the action planner, allowing the
 site manager to assign actions, set deadlines and monitor progress. A resolved issue becomes a
 compliance statement on your register.
- Clause 10.3 Continual Improvement An important clause within ISO14001 that requires robust environmental management to enhance environmental performance. To improve, the organisation needs to take action to correct mistakes, innovate, reorganise aspects that don't work, and continually improve all of which is supported via iCOR.







Aligning with ISO45001

iCOR also focuses on ISO45001 clauses that organisations struggle most with, including:

- Clause 6.1.3 Determination of Legal Requirements and Other Requirements Organisations are required to have access to, and maintain awareness of health & safety legislation. Answering iCOR's simple audit builds your organisation's bespoke compliance register.
- Clause 6.1.4 Planning Action This clause focuses on planning actions to address risks and
 opportunities, including legal compliance and prevention of work-related injury or ill health.
 iCOR determines the sufficiency of your controls, writes your compliance statements, and
 identifies gaps where regulatory requirements or internal commitments may not be met.
- Section 7 Support This section relates to resource allocation, competency, awareness and communication, all supported via iCOR's action planning function, and mechanisms for team collaboration. Often, solutions for compliance when planning action are additional training and communication strategies to embed health and safety into daily operations.
- Clause 9.1.2 Evaluation of Compliance Your answers to iCOR's audit questions related to workplace activities and risks serve to determine your compliance status at any given time. Risks are identified in relation to key health & safety areas in order to prioritise your action planning.
- Clause 9.1 Monitoring, Measuring, Analysis and Evaluation This clause requires accurate and consistent results to support effective decision-making and performance evaluation. iCOR visually represents audit outcomes, showing your organisation's current 'status of compliance' and areas of conformity. The timeline function tracks performance over time, while incident reporting allows you to raise and manage health & safety concerns proactively, ensuring effective documentation and response.
- Clause 10.2 Non-Conformity and Corrective Action This clause requires organisations to
 implement processes for managing non-conformities and taking corrective actions. iCOR
 automatically identifies your compliance gaps and transposes them into the action planner.
 Actions can be assigned, deadlines set, and progress tracked. Once resolved, these become
 compliance statements within your register.
- Clause 10.3 Continual Improvement A core requirement of ISO 45001 is to continually improve OH&S performance. iCOR supports this by enabling you to correct issues, implement innovative solutions, adapt processes, and track progress within one system which is designed to drive long-term improvement in health and safety outcomes.






Auditing with iCOR

Environmental and health & safety audits can be seen as necessary burdens that often highlight areas where your organisation may be under-performing or at risk of breaking the law.

A consultant or auditor will find these areas and report them back to you. It's a process that is time-consuming and results in a lengthy audit report being delivered a few weeks later, which still requires your review and interpretation to determine your next steps.


How does iCOR help?

With iCOR, you can audit yourself using an intelligent questionnaire. This will then populate your legal register, show you where you're not conforming, and allow you to assign actions to your colleagues in order to comply with environmental and health & safety legislation.




The questions have been written by our environmental and health & safety compliance experts in the simplest language possible, and the questionnaire will dynamically change its path depending on your answers, meaning that your questions will remain relevant.

The questionnaire will also remember your answers from the previous audit, which makes the process incredibly quick for future audits.




Upon completion of the audit, reporting is in real time. You're presented with your areas of non-conformity, and a list of audit results that require action. These can be assigned to your colleagues, making it easy to track your progress and add accountability to these areas of improvement.






As this is instant, you can get a snapshot of how your site is performing in as long as it takes to run through another audit. This is a significant improvement in speed and clarity of your audit results from a traditional consultant-led audit.

Prove it

Everything that you do in iCOR, from the audits you complete (including every answer you give), to the actions you tick off, is evidenced in your organisation's timeline.

Maybe you'd like to see how many monthly reviews our compliance experts have performed between your audits. It's all possible here.

Your hard work paying off

Each time you indicate that your organisation is doing something right, iCOR will ask you to provide evidence. This will all be recorded in neat report cards that will be included in your timeline.

Security

We want to assure you that your data is safely stored on our system. Data security should be high on an organisation's agenda, and we take it very seriously.

Robust Server

We use a strengthened and constantly monitored cloud server. It is protected by an advanced firewall to block attacks and perform scans for malicious code.

Data Encryption

Data in transit is secured by an SSL certificate, using both TLS 1.2 and 1.3, the latest and most advanced encryption protocols.

Maintenance

We maintain and update all of our server software on a monthly basis. We use only known, trusted partners in our software development and systems.

Users

Only specific user roles and administrators can access company data. Other than our administrators, no roles have permission to make system changes. User numbers are monitored and restricted where necessary for security.

Backups

In addition to daily server-side backups, full site backups are performed and stored externally to the server. These are only removed upon a request for user data to be 'forgotten'.

Penetration Testing

This testing highlights any holes in security, and is performed every six months by a third party. Any critical issues would be fixed as a top priority.


